Dr. Robertson is a marine biologist and is the Marine Project Manager for the San Juan County Marine Resources Committee. Her area of research and expertise focuses on how marine mammals interact with, and respond to, human activities and changes within their environment. Lovel Pratt is the Marine Protection Program Director for the Friends of the San Juans, a nonprofit dedicated, in part, to the health of the marine ecosystem. Ms. Pratt is active in monitoring maritime shipping and oil spill prevention.

Around the League - State & National Issues

The League of Women Voters of Washington will convene its biennial Convention on Thursday, May 4, 2023 and end on Sunday, May 7, 2023 at the Pasco Holiday Inn Express and Suites.

The business of Convention will set the stage for the 2023-2025 biennium and will include adoption of Program of Work, election of officers and board of directors, approval of budget, and approval of bylaw amendments. There will be a variety of workshops addressing key issues and tips and ideas from other Leagues for League work.

Additional Convention details will be continually added. The final business for Convention will be posted by March 25, 2023 (as per bylaw requirement).

Plan now to attend—each local League may send their President and additional delegates as determined by your membership count that is finalized with LWVUS on Jan. 31, 2023. Anyone may attend as an observer. Delegates chosen by the members of local Leagues and can have one delegate for its first through 15th voting members and one delegate for every 25 additional voting members or major fraction thereof.

This is a great place for new and long-term members to learn more about the League, meet members from across the state, and be inspired about our next 100 years. Bring friends who might want to discover the League and family who can uncover the hidden gems of our region. All are welcome!

Support Voting Rights in Washington!

ESHB 1048 (Enhanced Washington Voting Rights Act) passed the house with a vote of 57 - 38 and is already scheduled for both a public hearing and executive session this next week. This bill amends sections of the Washington Voting Rights Act to clarify what constitutes a violation of the act. It also seeks to protect members of classes who do not have an equal opportunity to elect candidates because of barriers like vote dilution or polarized voting. ESHB 1048 is an important upgrade to the 2018 Washington Voting Rights Act—and it needs your support now!

Local Providers discuss End-of-Life Decisions

Presentation of options, planning, legal concerns By Paula Hunt – Peninsula Daily News

Talking about your end-of-life wishes could be the toughest conversation you ever have with a partner, a child or a loved one, but it's necessary if you want to exercise control over the care you receive and how it is administered.

"How you advocate for your own needs and wants in medical care is important and makes a huge difference in what type of care you get," said Cassa Sutherland, client services manager with End of Life Washington, a nonprofit advocacy and support organization.

She joined local health care providers on a panel about end-of-life choices presented Feb. 26 by the League of Women Voters of Clallam County at Peninsula College's Little Theater. The 255-seat space was about two-thirds full.

When it comes to making decisions about the end of your life, you need to start planning and preparing now if you haven't already, Sutherland said. The risk in not doing so might mean receiving medical treatment you don't want, having people you don't know or wouldn't have chosen determining your care or losing control of how you want to die.

- Reclamation of valuable materials that can be used to make new batteries or other products
 - Prevention of release of toxic materials
 - Establish an extended producer responsibility program that will shift costs to manufacturers
 - Encourage manufacturers to improve battery design
- Decrease environmental pollution caused by fires and protection of recycling and garbage trucks, transfer stations and contracted facilities, and workers from battery-caused fires
