## Save The Date for our Annual Holiday Luncheon December 11<sup>th</sup> - The Grange, Friday Harbor

Our speaker will be Vince Dauciunas, Board Member at Opalco, District 1. Vince believes that the coming years are likely to be challenging because of the realities and politics of energy, global economic uncertainties, and climate change. It is vital that all organizations in the County responsible for the infrastructure be prepared to respond to these challenges.

OPALCO will continue to meet members' need for reliable electric power. Given the above concerns, a long-term plan should be put in place to ensure that the power supply remains secure and affordable. As a member of the Board, Vince believes OPALCO should actively support energy conservation and efficiency efforts and encourage member and community owned renewable energy generation systems. He will share some of these insights with us at our meeting.

### Redistricting - Why is it so important?

The League of Women Voters WA is spearheading a statewide effort to reform the current legislative and congressional redistricting process. Washington's efforts are part of the People Powered Fair Maps initiative of the national League in its bid to protect democracy. Washington State is one of only 9 states in the country that has a commission that draws district maps after the decennial census. Independent commissions are generally lauded as a way to reduce gerrymandering and base redistricting on a set of carefully considered criteria. Unfortunately, Washington's commission, which was created in 1983, no longer meets the needs of residents. There have been significant changes in demographics in WA that call for expanded representation on the Commission and our political climate demands stronger transparency and accountability methods for devising legislative and congressional maps.

Despite a legal commitment to be transparent, the 2021 Washington State Redistricting Commission worked behind closed doors in violation of the Open Public Meetings Act and rushed to approve incomplete maps. In fact, they missed the constitutionally mandated deadline for releasing its maps of new districts. Incumbent protection and partisan interests biased district line decisions. The State Supreme Court let the maps stand despite the missed deadline. Since there was little time to perfect maps, even noncontroversial modifications were not made. The commission settled lawsuits for their lack of transparency and for illegally firing an employee. The situation worsened when, in August 2023, a federal court judge declared that Yakima Valley Legislative District 15 is discriminatory against Latino residents under the 1965 Voting Rights Act. District lines must be redrawn before the 2024 elections. To comply, changes will need to be made to LD15 and the surrounding districts in order to correct the maps. Washington State deserves better.

The LWVWA Redistricting Reform Campaign Taskforce is calling for People First Redistricting - a process that puts people's interests above partisan tradeoffs. People First Redistricting maximizes opportunities for people to engage, ensures the broadest possible representation, is transparent and accountable and produces maps the people of Washington can believe in. To achieve People First Redistricting, we will need a state constitutional amendment to change in the composition of the commission and bills to improve to the commission processes. At present, there are four voting members of the commission, all of whom represent their political parties, plus a non-voting chair. More than 40% of the people in Washington State do not identify with either major party and they are not represented in the current commission structure. People First Redistricting would have additional seats on the commission for those who are not tied to a political party.

The LWVWA RRC Taskforce has been meeting with experts in other states to learn more about their redistricting processes. The Taskforce has developed a campaign strategy and is currently convening local area action teams. ## Around the League - State & National Issues

[SEATTLE, WASHINGTON] – The League of Women Voters of Washington President Mary Coltrane released the following statement condemning the interference with state elections offices:

"Sending suspicious substances to an election's office is an attack on democracy and could have put hard-working elections officials in danger. The League of Women Voters of Washington calls on candidates and political party leadership to issue statements condemning efforts to disrupt our elections. The League urges political party leadership to engage their constituencies in conversations that emphasize their sacred duty to protect our democracy by protecting our election workers and our ballots.

"Washington is a mail-in ballot state which provides voters with more accessibility to participate in elections. Voters need to trust that our elections will be secure and that those who seek to disrupt our democracy and risk the public health will face consequences. We stand in solidarity with all the election workers continuing to count ballots from Election Day and we remain committed to making democracy work."

#### The Election's Over - Now What?

You've cast your vote - so now what?

There's much more you can do to defend the issues that matter most even after you've submitted your ballot.

Here are a few actions you can take.

#### **Check State-Specific Results Timelines**

Election Day isn't results day; election workers will be hard at work for a while to come counting every ballot. Find out when <u>your state elections</u> are estimated to be complete at VOTE411.org.

#### Make sure your mail or provisional ballot is counted

If you voted by mail, go to <u>VOTE411</u> and click your state to find a link to your state's ballot tracking tool. Use the tool to look up your ballot and verify that it was counted. If it was not, call your local election official to figure out if you need to take action to verify your ballot.

If you voted a provisional ballot at your polling place due to a lack of ID, be sure to follow up with your local election official to provide the required ID and have your ballot counted.

#### **Fight Post-Election Mis- and Disinformation**

Mis- and disinformation are major threats to the democratic process. They're especially active after elections, with people sharing inaccurate stories about election results, the voting process, and who's casting their ballots.

Use these tips to identify mis- and disinformation across the media.

You can also report mis- and disinformation here.

#### **Demand Congressional Action**

With newly elected people set to take office in 2023, it's important to let them know which actions you stand for.

You might demand that they:

- Enshrine equality of the sexes in the Constitution with the Equal Rights Amendment
- Prevent voter discrimination with the John Lewis Voting Rights Advancement Act
- Work across the aisle to protect voting rights
- Create more financial transparency in elections

#### Get Involved

## LWV Lobby Team Gears Up for Action Workshop
