Bills Seeing Action This Week

[SB 5670](#) Creating additional middle housing near transit and in areas traditionally dedicated to single-family detached housing. Creates additional middle housing near transit and in areas traditionally dedicated to single-family detached housing, would amend the Growth Management Act to require cities over a certain size to include middle housing, such as courtyard apartments and townhouses, in single family neighborhoods; with technical assistance from the Department of Commerce.

[SB 5818](#) Promoting housing construction in cities through amendments to and limiting appeals under the state environmental policy act and growth management act. Promotes housing construction in cities through amendments to and limiting appeals under the state environmental policy act and growth management act, would encourage cities to increase density and development in areas supported by commuter or light rail or frequent transit service with a variety of incentives including appeal rights under SEPA and GMA for the ordinances (note that does not remove the requirements under SEPA for the actual construction).

[HB 1880](#) Concerning housing benefit districts. Relates to housing benefit districts, would authorize certain jurisdictions to establish a housingbenefit district within their city boundaries for the purpose of acquiring, land banking, predevelopment contracting, selling, improving, funding, and leasing land for the creation of affordable low-income and middle-income housing and community development projects within their city boundaries.

Bills We Support

Public hearings were held last week on several housing related bills that the League supported. See the page on Growth Management for additional related bills.

[HB 1593](#) Expands the landlord mitigation program to alleviate the financial burden on victims attempting to flee domestic violence, sexual assault, unlawful harassment, or stalking.

[HB 1724](#) Ensures oversight and coordination of permanent supportive housing resources to maximize the creation of high quality housing opportunities for people living with disabling conditions in communities across Washington.

[HB 1601](#), Relates to the student homelessness pilot, expanding the prior pilot project to all community and technical colleges.

[SB 5566](#) Expands eligibility for the independent youth housing program.

[SB 5576](#) Addresses landlord-tenant relations by providing technical changes to eviction notice and summons forms and modifying certain eviction processes and programs.
