The League of Women Voters of Jefferson County (LWVJC) has created three informational videos that focus on running for and serving in public office. These videos, comprised of Q&As with city and county officials, were conducted via Zoom and are [available for viewing on the LWVJC website](#), along with transcripts of the videos, as well as on the [LWVJC YouTube page](#).


and what's expected of them as officeholders. The LWVJC encourages other League chapters to view these videos and then create videos of their own tailored to their region's specific needs and procedures.

Because the LWVJC could not give extra airtime to candidates in an election year, unit-at-large president Angela Gyurko spoke with current Port of Port Townsend commissioners, Chimacum and Port Townsend school board members, and Port Townsend City Council members who were not running for election during the calendar year. In addition, due to open meeting regulations, no one discussed any past, current, or future issues that the officials might be called upon to address during their time in office.

Questioning began with how long people served in office, why they decided to run, their campaign strategies, and the financial costs of campaigning. From there, Gyurko moved on to how much time per week officeholders spend fulfilling their obligations, what duties occupy the bulk of their time, the rewards of serving, the extent to which their jobs and commitments differ from what they had anticipated before serving, and what advice they would offer anyone considering running for office.

The videos also reminded viewers of the week in mid-May during which they can file as candidates for office and provided the county website address for complete filing information.

If other chapters across the state are considering creating videos for their areas, the LWVJC would be happy to share the lessons it has learned regarding scheduling, technology, working within legal constraints, and preparing accurate, yet readable, transcripts. 

The virtual forum will be held as a town hall panel discussion with audience questions and answers.
