## LWVSJ Happenings

### September 9, 2019 – Membership Meeting

#### Healthcare: Two Options

Our speakers were John Geyman M.D., Professor Emeritus of Family Medicine-University of Washington and Linda McCarthy, Executive Director of the Mt. Baker Planned Parenthood (MBPP). Also present was Jennie Noskoff, Development Manager at MBPP.

The meeting was opened to a full house by President Barbara Sharp. Steve Bowman introduced the speakers and served as moderator for the ensuing questions for each speaker. Dr. Geyman and Ms. McCarthy were both asked to address the current issues regarding healthcare options in today's political climate and how it affects residents of San Juan County.

Ms. McCarthy spoke first and gave the audience some background information on MBPP since its inception in 1969 and its extension of services to San Juan County in 1995. She outlined the services provided: medical services, education and advocacy. Of over 15,000 visits to Planned Parenthood facilities in 2018, 96% of services were attributed to cancer screenings, contraception, STD screening and treatment, pregnancy testing and gender affirming hormone therapies. These

statistics underscore the overall value of the wide range of medical services provided by the PP offices. That same year, the MBPP educators and Teen Council provided 318 community programs and taught 4040 participants in their education program for that year. The age range of those taking part was 6 -60 years old.

Linda also brought to our attention the state of the Title X Family Planning program that provides affordable birth control and reproductive healthcare to people struggling to make ends meet. Every year four million people access critical health care services through Title X, including birth control and breast cancer screenings. PP operates 56% of the Title X health centers in Washington. Unfortunately, the current administration's Title X "Gag Rule" imposes new restrictions designed to make it impossible for patients to get birth control or preventive care from health care providers like PP as long as the PP clinics refer patients for abortion services. These restrictions violate Washington's informed consent law (requiring physicians to inform patients of all medical options) and are a direct attack on health centers that provide services in low-income communities. Effectively, PP has been forced out of the program and it has become harder and harder for them to access any of the available funding. A court case will be heard in late September to decide if Washington will officially withdraw from Title X. It is imperative that our legislative representatives secure our Title X protections. Linda used the Colorado Family Planning Initiative, offering free long-acting, reversible contraceptives (LARC) as an example of success and cited the avoided costs in the period 2010 – 2014 to be over \$66 million dollars. She then gave the membership different ways in which each of us could fight back, vote and make a difference.

Dr. John Geyman then took the podium. He shared with everyone at the meeting his latest publication, *Common Sense: The Case for and Against Medicare for All*. His comments centered around the obvious need, yet still controversial topic surrounding a National Health Insurance program. (NHI) or "Medicare For All" as it is popularly known. Dr. Geyman quoted statistics surrounding reproductive healthcare – the fact that 47% of hospital beds in Washington state are in Roman Catholic hospitals where contraception is not supported. Stakeholders in both the private hospitals and insurance companies want to keep things the way they are. Insurance policies are not affordable and are unsustainable. A family with an income of \$50k per year could be expected to spend \$28k on health insurance. John stated that the three apparent options on the table are to build up the Affordable Care Act, to develop a NHI plan (Medicare for All) or the plan from the Republicans, still to be released. The public option for Washington is very much still a work in progress and he thinks that it will not work due to pressure from hospitals over rate settings and many will refuse to operate it and hand it off to

private insurers. This will ensure the failure of the program and not address the problems of universal access.

Dr. Geyman spoke in detail about the importance of the current bill in the House, HR1383 (health insurance for all with equity for all US residents). It currently has 80% Democratic and 52% Republican support. Employer based insurance cannot be depended upon, last year alone 66 million people left jobs. Government policy has always been to be very friendly with the insurance industry and without fundamental change in our financing system we will not be able to effect the necessary transformations.

He concluded his talk by bringing to the audience's attention that there are currently four new candidates running for the hospital district and they need our support to bring about necessary reforms.
